LVMPD Searching for Suspect Who Killed One Person, Injured Another at Company Picnic

On April 15, 2018 at approximately 5:45 p.m. patrol officers responded to Sunset Park located at 2601 E. Sunset to investigate reports of a shooting. Arriving officers located an adult woman and an adult man suffering from gunshot wounds. Medical personnel transported the victims to Sunrise Trauma. The woman was pronounced deceased at the hospital and the man is currently in critical condition.

The preliminary investigation by LVMPD Homicide indicates that 42 year old Anthony Wrobel showed up at an employee picnic hosted by the Venetian Hotel at Sunset Park. Wrobel walked up to the victims who were seated together at a table in the gazebo area. He then pulled out a handgun and shot both victims at close proximity. Wrobel then ran to the parking lot and fled in a black and purple Dodge Charger. The vehicle was located a short time later in terminal three parking garage at McCarran International Airport.

This appears to be an isolated event of workplace violence and detectives believe the victims were specifically targeted. As of this release, Wrobel has not been located. He is described as a white male adult, 5 feet 9 inches tall, weighing approximately 197 pounds. Wrobel who has been described as disgruntled, is a current employee of the Venetian. He's been employed at the hotel for 14 years.

***** Update *** Suspect Arrested *** Update *****

In the early morning hours of April 19, 2018, a deputy with the Oldham County Sheriff's Office in Vega, Texas was on routine patrol and conducted a registration check on a Cadillac DeVille with a Utah license plate at a rest stop. When the license plate returned as stolen, deputies made contact with the occupant of the vehicle and conducted a records check on the Vehicle

Identification Number (VIN). That check indicated the vehicle was associated with Anthony Wrobel who was wanted for murder and attempted murder in Las Vegas. Wrobel was also positively identified by deputies and was taken into custody and transported to the Oldham County Jail. Wrobel is waiting for arraignment on the fugitive charges and extradition to Las Vegas.
