## Two People Found Dead in Hotel

On June 1, 2018 at about 4:04 p.m. LVMPD patrol officers were dispatched to a hotel located at 2880 South Las Vegas Boulevard to investigate a report of two people found deceased in one of the guest rooms. Arriving officers located an adult male and adult female inside one of the rooms deceased from apparent stab wounds.

The investigation initiated by the LVMPD Homicide Section indicated the two people were tourists from outside of the country and had arrived the day before as part of a tour group. The victims did not show up for a tour that was scheduled for the morning of June 1, and one of the members of the tour group was concerned when the victims could not be contacted throughout the day. The concerned party asked for a welfare check later that afternoon, and when security officers entered the room they discovered the victims deceased and contacted police.

Lieutenant Ray Spencer of the LVMPD Homicide Section met with members of the media today to show surveillance photos of a suspect in this incident. The suspect was seen on surveillance video going up in the elevator to the top floor of the hotel just after 4 a.m. on June 1, 2018. He was then seen leaving the elevator at approximately 4:45 a.m. When the suspect left the elevator, he was wearing a backpack that is believed to have belonged to the male victim.

The suspect was described as a light-skinned black male adult who appears to be between 25 and 30 years of age. He was last seen wearing a blue and grey baseball-

style tee shirt with some kind of logo on the front, black Adidas pants with white stripes down the side, and black shoes. He had some kind of a tattoo that could be seen on his back just below his neckline.
